### **1. Governing Terms**

### **2. Acceptance of Terms**

By signing below, the Applicant agrees to be bound by the SF&B, LLC Terms and Conditions of Sale, the Applicant's purchase order, SF&B's order confirmation or invoice, this Credit Application, and any Individual Guarantee, if applicable (collectively, the "Agreements"). These documents constitute the exclusive terms governing the sale and purchase of goods between SF&B, LLC and the Applicant. The Agreements may not be modified except by a written instrument signed by both parties.

### **3. Authorization to Verify Credit**

By submitting this application, Applicant authorizes SF&B, LLC to make inquiries into the Applicant's banking, trade, and business references provided herein.

### **4. Accuracy of Information**

**c. Applicant agrees to pay a \$25.00 fee for each returned or non-sufficient funds check.**

**d. Applicant agrees to pay all reasonable costs of collection incurred by SF&B, LLC, including attorneys' fees, court costs, and related expenses.**

**8. Credit Terms Modification**

**SF&B, LLC reserves the right, at its sole discretion, to change credit terms, credit limits, or suspend or terminate credit privileges at any time.**

**9. Delivery, Title, and Risk of Loss**

**Delivery of goods is F.O.B. the Seller's warehouse. Title and risk of loss or damage pass to Applicant upon transfer of goods to the common carrier. SF&B, LLC shall not be liable for any direct, indirect, special, incidental, or consequential damages resulting from shipment delays.**

**10. Governing Law and Venue**

**This Agreement shall be governed by the laws of the State of Colorado, without regard to conflicts-of-law principles. Exclusive venue for any dispute arising hereunder shall be the District Court of Boulder County, Colorado. Applicant waives any objection to venue or jurisdiction and consents to litigation in such court.**
